

Board Meeting Draft Minutes March 30, 2023 9:00am Teams Call

Board members present: Mark Doyle, Dennis Doyle, Walter Garigliano and Eric Ooms Staff: Todd Erling and Mary Ann Johnson

Mark called the meeting to order at 9:09

Todd started the meeting by announcing HVADC had received word that the organization achieved CDFI certification status on 3/29/22. HVADC is now eligible for financial aid awards from the CDFI upon a successful grant application. Mark asked about the interest rate structure with this money. Todd noted the funds would be granted to us and not an intermediary loan that we have to pay back.

Walter made a motion to amend the HVADC bylaws to add a position of Director Emeritus – Eric offered a 2^{nd} . The Board voted unanimously in favor.

Mark asked if the members reviewed the Minutes from 10/31/22. Eric made the motion to accept the minutes and Walter offered the second. The Board voted unanimously in favor to accept the minutes.

The financials were discussed with Mary Ann noting the grant advance from Ag & Markets on the balance sheet. The Board discussed the individual county contracts.

Board member Ann Finnegan joined the meeting at 9:20.

Todd presented the audit and the members indicated they had reviewed. Walter noted the audit was what he expected. Eric moved to accept, and Walter offered a second. The Board voted unanimously in favor of accepting the audit.

Board eval – MA reviewed that it is aggregated and returned to ABO.

Meat Processing Expansion Grant – HVADC is the administrator for the Ag & Markets program. Partners in the region have indicated they have businesses interested in and awaiting applications. Todd noted a review committee with statewide representation will be formed to review and score the applications.
